UDI-ER Briefing Note: City of Edmonton Fall 2019 Supplementary Budget Summary

OVERVIEW

- On Friday, December 13, 2019, following three days of budget deliberations, Edmonton City Council approved the fall 2019 supplementary operating & capital budget adjustments.
- o The vote was 11-2, with Councillor Walters and Councillor Nickel voting against.
- This will result in a property tax increase of 2.08% in 2020 (1% going to the Edmonton Police Service, 0.8% to the LRT and the remaining 0.28% for growth in infrastructure and services).

BACKGROUND

- o In accordance with the City of Edmonton's Multi-year Budgeting Policy, Council approved the 2019-2022 operating & capital budgets in December, 2018.
- However, supplemental budget deliberations still occur twice a year once in the spring and once in the fall.
- Due to reductions in funding via the recent provincial budget, the City was faced with a shortfall of \$209 million in 2020 - \$26 million to the operating budget and \$183 million to the capital budget.
- While property taxes were originally set at 2.6% in 2020, the reduction in provincial funding increased this figure to 4.3%.
- o In response, City Administration provided Council with Options to Further Reduce [the] 2020 Operating Budget.
- Attachments to this report provided Council with reduction strategies the City could implement to either maintain a 2.6% tax increase or implement a 0% tax increase, for 2020.
- During deliberations, Council made certain spending reductions and ultimately arrived at a 2.08% increase for 2020.
- o The following table illustrates the aforementioned tax increase discussion:

- Certain projects requiring capital funding were either deferred and/or reduced in scope – including the Lewis Farms Community Recreation Centre and Library. However, other projects still received funding approval – such as the 105th Avenue (Colombia Avenue) project, the planning and design of the 170th Street Footbridge, the planning, design and delivery of a portion of the Terwillegar Drive Expressway Upgrade, and the planning, design and delivery of the Stadium LRT Station Upgrade.
